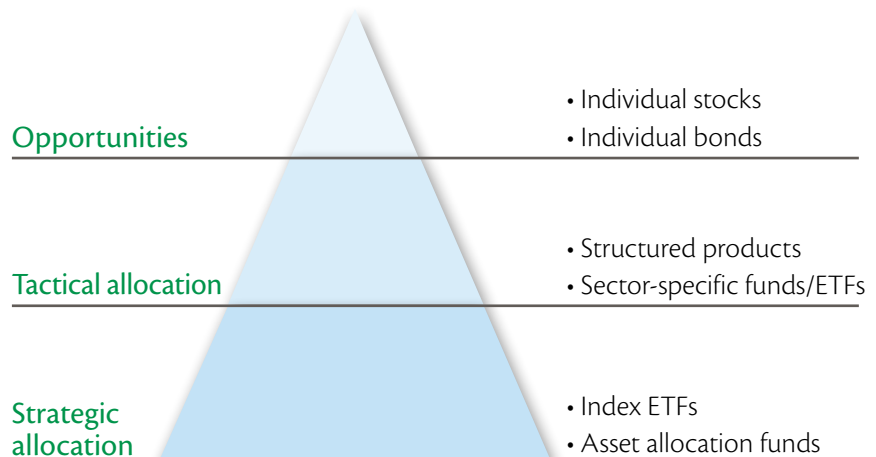
Dedicated investment specialist
