BCV account terms and conditions

Effective from 1 February 2021





This brochure provides you with information on the fees and conditions applicable to your banking transactions. It is also available online at www.bcv.ch.

Should you require any further information, please contact our advisors at 0844 228 228. They are available from Monday to Friday, 7:30am to 7:30pm.

General information

Our fees and conditions may be changed at any time without notice. Fees are applied in Swiss francs or the foreign-currency equivalent. You can find these updates on the BCV website, www.bcv.ch.

Interest rates are available at our branch offices and on our website (www.bcv.ch). If the interest earned on an account totals CHF 200 or more, or if interest is calculated on the account more than once a year, a 35% withholding tax is levied.

Where mentioned, VAT (currently 7.7%) is billed additionally to customers domiciled in Switzerland or Liechtenstein. Some services, such as the rental of safe-deposit boxes and purchase of BCV e-code readers, are always subject to VAT.

Outside charges

Costs invoiced to us by couriers, the Post Office or other banks will be billed to the originator or the beneficiary. Costs incurred for specific services will be charged to the originator based on the complexity of the services provided. When mailing documents, BCV charges postage fees per envelope sent (for accounts to which this type of fee applies).

Conditions governing check deposits

BCV will pass on to the customer any costs not specifically provided for in these terms and conditions (such as postage and telephone charges) – and fees charged by correspondent banks – unless they are paid by the drawer. If a payment requires additional correspondence, the customer will be charged for the resulting work and costs.

BCV shall not be bound by any instructions the customer may give regarding the collection process.

For amounts credited subject to collection, BCV shall credit the currency equivalent of the check as such. Should the payor bank subsequently refuse to make the payment, BCV reserves the right, pursuant to the subject to collection provision, to debit from the customer's account the currency equivalent of the check calculated at that day's rates and any fees incurred.

The value date depends on the corresponding collection method and may be that same day or any day within the following 6 weeks.

The customer acknowledges that all checks drawn in the US or Canada are subject to US or Canadian law, respectively, which govern liability concerning the authenticity of checks and all endorsements.

The customer undertakes to fully compensate BCV should legal proceedings be brought against BCV by a correspondent bank because checks presented for cashing have fake endorsements or other irregularities.

The ICC Uniform Rules for Collections and BCV's General Conditions also apply.
