Management fees

1.00% p.a. (0.75% p.a. for the Investment Manager and 0.25% p.a. for the Issuer) to be deducted on a pro rata basis from the cash component in USD. If the amount available in the USD cash component is insufficient to cover the management fees, weightings will be adjusted in order to cover the fees.

Transaction costs at rebalancing

0.10% by rebalancing calculated on the rebalanced nominal amount (including currency swap transactions) and 0.15% for the portion of the rebalancing processed in CNY.

Stock-exchange fees and duties

When the underlying stocks are traded on an exchange that levies taxes, transaction fees, and other fees related to buying and selling stocks, these taxes and fees will be factored into the execution prices and will thereby affect the Certificate's performance. These taxes and fees could include a federal stamp duty or financial transaction tax.

Roles and responsibilities

The Investment Manager selects the securities in the basket, as well as the weighting of the securities and any cash component, in accordance with the investment universe and rules (see below).

The Certificate's performance therefore depends on the quality of the Investment Manager's investment decisions. The Investment Manager takes full responsibility for the composition of the basket and its impact on the Certificate's performance.

The Issuer shall execute the buy and/or sell orders necessary to issue or rebalance the Certificate on a best effort basis.

Investment universe

The shares must be listed on the SIX Swiss Exchange or a foreign stock exchange with equivalent regulations.

In general, the underlying strategy invests in climate change mitigation. The companies selected for the basket contribute to meeting various UN Sustainable Development Goals: climate action (Goal 13) and affordable and clean energy (Goal 7).

Investors can obtain information about the investment strategy free of charge from the Investment Manager.

Management rules

1. The Investment Manager may rebalance the basket no more than 20 times per year.
2. The basket shall contain at least 5 underlying assets but no more than 60.
3. Stocks in the basket shall be denominated in CHF, USD, EUR, GBP, AUD, NZD, CAD, SEK, NOK, DKK, JPY, HKD, SGD, KRW, THB, MYR, TWD or CNY.
4. A currency hedge can be taken out (default 3 months for swaps) or wound up during the lifetime of the product, as the Investment Manager sees fit. Non-deliverable currencies cannot be hedged
5. The minimum market capitalization of the companies must be USD 0.5bn.
6. During a rebalancing event, the weighting of a new stock may not exceed more than half of the average daily volume traded during the last 5 days.
7. The cash component may not exceed 50% of the total nominal amount invested.
8. The weighting of collective investments (such as an investment fund or an ETF) not authorized for distribution in Switzerland, or reserved for qualified investors, must not exceed 1/3 of the overall value of the Certificate at each rebalancing.
9. During the Certificate's lifetime, dividends (net of any taxes and fees) will be reinvested in the respective underlying assets.
10. Secondary market trading of the Certificate will be suspended during rebalancing periods.
11. Should allocation limits be exceeded, adjustments shall be made at the next rebalancing.
12. Any technique intended to create a leverage in the basket is prohibited.

Investment restrictions

If a stock cannot be traded for liquidity reasons or if it is impossible to execute a transaction for technical reasons, it may take the Issuer some days to implement the Investment Manager's investment decisions. Based on these elements only, no guarantee can be made as to whether investment decisions will be implemented on the same day that instructions are received.

The Issuer reserves the right to refuse to execute a buy order if the security in question is subject to an investment restriction. Securities with an investment restriction include companies that represent a reputational risk for the Issuer and companies that are not in keeping with the Issuer's code of conduct (for instance, the Issuer does not currently invest in any company involved in cluster munitions).

If a selected security no longer complies with the investment restrictions set by the Issuer, the security must be replaced at the next rebalancing.

Terms and conditions

Redemption of Certificate

The amount redeemed in USD is calculated by multiplying the average selling price for each underlying assets by its quantity in the basket, converting the product into USD, and then adding any proceeds from the unwinding of the final currency swaps and from the portfolio's cash holdings. The formula for this calculation is as follows:

P_i = the average selling price of underlying assets i at the final fixing date of the reference exchange

n_i = the quantity of underlying assets i in the basket at the final fixing date

N = the total number of underlying assets in the basket

S_j = the value of currency swap j

t_i = the exchange rate between the currency of underlying stocks i and that of the Certificate at the final fixing date, which BCV shall determine as it deems appropriate, in accordance with market conditions

T = the total number of currency swaps

C = the amount of the cash component per Tracker Certificate

Stop loss

As the value of the currency swaps could be negative, the Certificate will mature immediately if its net asset value (i.e., its selling price) falls to 7% of its issue price (i.e., USD 7.00). The Certificate may be redeemed early under the terms set out below.

Liquidity risk at the moment of redemption

If daily liquidity strongly influences the sale of the component stocks of the Certificate, the issuer reserves the right to place sale orders over several days in order to prevent repercussions on the redemption price of the Certificate.

Issuer's right of termination

The Issuer has the right to terminate all Tracker Certificates in circulation at any time, but no earlier than 9 months after the issue date (please note that if the total number of Certificates in circulation falls below 2,000, the Issuer will automatically redeem all Certificates). The termination must be announced at least 1 month prior to the effective termination date. The redemption amount will be calculated on the effective termination date.

If during the product's lifetime the Certificate's price drops to 25% of its issue price or below, the Issuer may also immediately terminate the Tracker Certificates without prior notice. The effective termination date shall be announced as soon as possible.

Investor's right of termination

Investors may sell their Tracker Certificates on the secondary market. They also have the right to terminate any or all of the Certificates they hold provided that the Issuer has not already exercised its right of termination. The investor may do so once per quarter, on the last Tuesday of the quarter, but no earlier than 9 months after the issue date.

The notice of termination must be sent to the calculation agent at least 1 month before the effective termination date, in line with the termination procedure set out below. The redemption amount will be calculated on the effective termination date.

Termination procedure for investors

For the investor's termination to be valid, the Issuer must not have already exercised its right of termination, and the termination notice must be received by the calculation agent at least 1 month before the effective termination date. This notice may be made via mail or email to the addresses provided under "Contact information: product redemption."

The investor's custodian bank must include the following information in its message to the calculation agent:

- name, address and clearing number
- the Tracker Certificate's security number
- the number of Tracker Certificates involved
- the effective termination date (must be at least 1 month after the notice is received by the Issuer)

The calculation agent will confirm the termination to the investor's custodian bank, specifying in particular the effective termination date.
